3) Walk-In Agenda Requests:

- Valley Paving IUP: Brent Carron appeared requesting an Interim Use Permit for a portable asphalt
 plant located at 9998 Co Road 66 in Belle Plaine. He explained that an EAW will be necessary
 because of the scope of the project. Supervisor Cox made a motion to approve the permit.
 Supervisor Schultz seconded. Township approved the request with the condition that the plant
 hours match the pit hours. Chairman Kornder abstained from voting.
- Drainage ditch assessments: after discussion it was decided that the Township will contact the Townships attorney to check on the validity of the assessments.

4) Other Business:

Annexation agreement: Township will also need to contact the attorney to look at the upcoming annexation agreement.

5) Road Reports & Issues:

- Susan Lane: Township was not happy with the way it as done. Brent Carron agreed and stated that the edge should be milled and then overlayed the whole way down. This will be one of the first jobs done in the spring. Brent said he would send a letter to the township stating the intent to complete the job and a deadline.
- Jeff Klehr was given approval by the Township to remove the trees in the right of way along Fabor.
 Mulch to be taken to Cox's home and dumped in a designated area in the parking lot. Supervisors
 Schultz and Cox will mark out the Right of way at the residents request and the Township will keep the resident informed about the progress.
