- 3) Walk-In Agenda Requests:**

Requests were called in the order of the arrival:

Dawn Meyer, Belle Plaines City Administrator came to address the Board as a “Good Neighbor” and to striethen the relationship between the Townships and the city. Scott Schmidt was here on behalf of the homeowner to get a recommendation from the Township to build a replacement storage structure at 10961 373<sup>rd</sup> W. The board granted the recommendation with the following conditions. The structure must stay within the allowable square footage by Scott County guidelines.

Chris Zwart came to follow up with his concerns about the dust coating by Rubies and Rust. The Board informed Mr. Zwart that the dust coating would be the same as last year. The Board also informed Mr. Zwart that the road signs that needed replacing were on order.
