3) Walk-In Agenda Requests:

- Resolution for Township Election Judges: Clerk De Voto presented a resolution to appoint election Judges for the August 9th Primary and the November 8th Midterm Elections. The resolution was accepted and signed.
- Recommendation for Removing a building Chris Bieder: Mr. Bieder really doesn't need a recommendation from the Township to move the building. The matter was placed on the agenda and discussed. Nothing further should be needed by the county.

4) Other Business:

- Meghan Darley and Troy Kuphal from the Scott SWCD came to give the Board members an overview of the Scott County Noxious Weed and Brus Control Program. This included a handout out lining the goals and objectives, services provided as well as what to expect going forward. We were informed that our road ways are fairly clean so the Township cost should be lower. It was discussed what the Township could do to keep the noxious weeds in check.
- Supervisor Schultz informed the Board that the state DNR has been putting up signs with the address of the property in the right of way. The board decided that the Township should write a letter asking the DNR to move the signs.
- Schultz will arrange for the Township Hall to be power washed.

- Susan Lane: Chairman Kornder will reach out for a quote for a black top overlay.
- Seal coating several areas was discussed A decision for next year should be addressed by February 2023. Kornder will get an estimate for the work scheduled.

- A resident reported that a neighbor has been seen removing gravel from the road. It was decided that the resident would be confronted and warned that if it happens again the Township would fine him.
